L-Carnosine in Cell Cultures

L-Carnosine is a natural dipeptide composed of two amino acids, β -alanine and L-histidine, and is found in high abundance in muscle, brain and other innervated animal and human tissues.¹⁻² L-Carnosine is a naturally occurring antioxidant and transition-metal ion sequestering agent.³⁻⁶ Indeed, L-carnosine was proven to scavenge reactive oxygen species (ROS) as well as alpha-beta unsaturated aldehydes formed from peroxidation of cell membrane fatty acids during oxidative stress. Apart from the function of protecting cells from oxidation-induced stress damage, L-carnosine appears to be able to extend the lifespan of cultured cells, rejuvenate senescent cells, inhibit the toxic effects of malondialdehyde and hypochlorite to cells, inhibit glycosylation of proteins and protein-DNA and protein-protein cross-linking, and maintain cellular homeostasis.⁷⁻⁹
